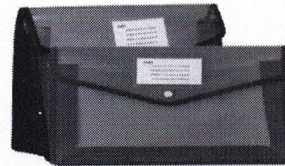

Student should scan document properly through computer scanner (Size 500 kb only). **Please don't use mobile scanner for scanning documents.** Individual Original Documents should be scanned and **renamed** appropriately. This submission will be mandatory to be submitted ONLY on pen drive.
